



MEMORANDUM OF AGREEMENT
between
FACULTY OF VETERINARY SCIENCE
CHULALONGKORN UNIVERSITY, THAILAND
and
FACULTY OF VETERINARY MEDICINE
UNIVERSITAS AIRLANGGA, INDONESIA



Faculty of Veterinary Science - Chulalongkorn University, Thailand and Faculty of Veterinary Medicine - Universitas Airlangga, Indonesia ("Parties") want to collaborate and cooperate with each other so as to promote the advancement of scientific and academic exchange and collaboration. They have entered into his Memorandum of Agreement ("MoA") to create a foundation from which such collaboration may be developed.

The Parties share a mutual intent to support and promote the spirit of this MoA by encouraging cooperation and collaboration as follows:

1. Exchange of scientific and instructional information;
2. Exchange of respective staff for research, teaching and other collaborative activities;
3. Exchange of respective staff to participate in conferences, symposium, workshops and seminars;
4. Exchange of undergraduate and/or graduate student for specific periods of study through an organized study abroad agreement;
5. Establishment of articulation pathway;
6. Establishment of joint research projects on subjects of mutual interest; and

Cooperative activities and exchange of research, teaching and publication will be developed when appropriate to the interests of the Parties in accordance with permissible financial circumstances.

The Parties recognize that the cooperative and collaborative activities referred to above will need to be conducted by way separate, written agreements. Those agreements will set out the Parties' various rights and obligations in respect of those activities.

This MOA will only be signed in English.

This MOA will commence on the date it is signed by representatives of both Parties and shall be valid for a period of 5 (five) years. This MOA shall be extended for a further 5 (five) years at the expiration date unless either Party gives written notice to determine this MOA at least 3 (three) months prior to the expiration date.

This MOA may be amended in writing at anytime by mutual consent.
